The Board discussed, but did not act on the following item: amending the meeting room policy in the Community Learning Center to require groups to only be able to book 60 days in advance, only being able to book during Library hours and renters must check in and out with Library staff. These items will be brought back at the January 17th meeting for discuss and possible action.

January 17th Village Board Meeting Preview

A public hearing will be held for the special use request to construct a wireless tower facility at 6101 S. 51st Street (St. Stephen the Martyr Lutheran Church). The public hearing was adjourned at the previous meeting. There will also be a public hearing for a special request from St. Alphonsus to demolish and rebuild the church rectory.

The Board will review requests to purchase police vehicles and general government vehicle per the 2017 Adopted Budget. The Board will discuss potential capital improvement projects for 2017 relating to street lighting, parks and road rehabilitation. The Board will again review the Community Learning Center policy to determine if changes should be made as recommended by the Library Director.

The Board will review special event permits for Fourth of July Family Fest, Village Days, Greendale Downtown Markets, Saturday Night Fun on the Green, Village Nights on the Green, Movie Nights at the Park and Winterfest. These events are similar to prior years with changes to Greendale Downtown Market (formerly Greendale Open Market) to include every Saturday from June 17 to October 7th. Also, "I Left My Heart on Broad Street" has been changed to "Winterfest" in 2017.

Village Board Meeting in Review

At the January 17th Board meeting the Board approved:

- A special use permit to St. Alphonsus Church at 5960 S. Loomis Road to demolish the existing church rectory and rebuild a new one on the same foundation.
- A temporary class B license for the Greendale High School Booster Club and for the Greendale Education Foundation and a Class A liquor license for 5629 Broad Street for a wine merchant.

The Board held a public hearing regarding a special use request to construct a wireless tower facility at 6101 S. 51st Street (property currently owned by St. Stephen the Martry Lutheran Church). The Board tabled this item until the February 7th Board meeting.

The Board also held a Special Village Board meeting on January 23rd in which the following items were approved:

- The purchase of 2 new police vehicles as included in the 2017 Budget.
- The purchase a vehicle for use by general government personnel as included in the 2017 Budget.
- To amend the meeting use room policy at the Community Learning Center to limit the number of reservations permitted by a group each year, limit the hours to only when the building is open, allow groups to only be able to only book 3 months in advance and to only permit informational, educational, cultural or civic events to be held there.
- The list of election officials for the 2016 & 2017 term.
- A special event permit for the Greendale Lions to hold the Fourth of July Family Fest from June 30 – July 4th.
- A special event permit for the Greendale Lions and Greendale Entertainment Association to hold Village Days August 11-13th.
- A special event permit for the Greendale Downtown Market (formerly Open Market). This year the market will be held every Saturday from June 17 – October 7.
- Special event permits for Gazebo concerts for Saturday Night Fun on the Greendale and Village Nites on the Green and for Movies in the Park.
- A special event permit for Winterfest (formerly I Left My Heart on Broad Street) scheduled for February 11th from 10 am to 4 pm. http://www.greendale.org/our_community/public_celebrations/winterfest_2017.php

The Board discussed, but did not act, on the 2017 Capital Improvement Projects including street lighting, parks and road rehabilitation. There was discussion on whether to resurface or reconstruct the tennis courts at the Community Center and which road and street lighting projects would be included this year. The Board will have a discussion on recycling and garbage carts. The Board will hold a closed session to discuss the special use request for a wireless tower facility at 6101 S. 51st Street.

Tuesday February 7th

The Board will consider a special use request to construct a wireless tower facility at 6101 S. 51st Street. The Board will also review an intergovernmental agreement between Milwaukee County and the Village of Greendale for Emergency Medical Services.

The Board will hold a closed session to discuss an intergovernmental agreement with the City of Greenfield to host the Village's public safety computer aided dispatch system and to discuss the development at 6200 W. Loomis Road.
