

**NOTICE TO ALL ELECTRICAL CONTRACTORS**

You are hereby notified that your license to do Electrical work in the Village of Greendale expires on **April 30, 2008**

The Municipal Code of the Village provides:

16.11 LICENSE REQUIRED

No persons, firm, or corporation shall alter, install, or repair electrical wires and apparatus for any purpose whatsoever in the Village of Greendale without procured a license in the Village. **All applicant's Must submit a copy of their valid State of Wisconsin Electrician certification with the license application.**

Licenses issued pursuant to the terms of this chapter shall not be transferable and shall not be used by persons other than to whom issued.

All electrical licenses shall be issued for one year commencing on May 1<sup>st</sup> and expiring on April 30<sup>th</sup> the following year.

16.14 MASTER ELECTRICIAN'S LICENSE – NEW/RENEWAL - \$50.00 FILING FEE - \$15.00 (New/Late applicants only)

An original license shall be issued upon the payment of a fee for \$50.00 plus filing fee of \$15.00. A renewal license shall be issued upon payment of the annual fee of \$50.00. Any license in effect shall lapse if not renewed by the first day of May each year. The renewal of such license thereafter shall be as an original license and require a fee of \$50.00 plus filing fee of \$15.00
