These are the minutes of a regular meeting of the Greendale Police & Fire Commission held on Wednesday, October 11, 2017 at 7:30am in the Court Room of the Greendale Safety Center, 5911 West Grange Avenue, Greendale Wisconsin.

Commission President Weyer called the meeting to order at 7:36am.

MINUTES

The minutes of the July 13, 2017 meeting were approved as published.

FIRE DEPARTMENT

Fire Chief Saidler discussed past activity for the Fire Department including an update on the two recently hired Firefighters.

POLICE DEPARTMENT

Police Chief Malasuk discussed past activity for the Police Department including an update on the recently hired Police Officer.

CLOSED SESSION

Commissioner Kuzmanovic announced the following motion, seconded by Commissioner Birmingham, and approved by the unanimous vote of the Commissioners present at the meeting, to adjourn into "Closed Session," pursuant to Section 19.85(1)(c), Wisconsin State Statutes to consider employment, promotion, compensation or performance evaluation data of any public employee over which the governmental body has jurisdiction or exercises responsibility, specifically, to discuss the result of the officer candidate interviews and create and approve a hiring list, subject to the results of the Chief's interview, background check and physical exam; as well as discuss an upcoming retirement in the Police Department.
