These are the minutes of a regular meeting of the Greendale Police & Fire Commission held on Wednesday, December 30, 2015 at 8:30am in the Court Room of the Greendale Safety Center, 5911 West Grange Avenue, Greendale Wisconsin.

ROLL CALL

All members were present for this meeting with Commissioners Kuzmanovic and Wilmoth present by conference call. Police Chief Robert Malasuk and Fire Chief Timothy Saidler were also present.

MINUTES

The minutes of the March 12, April 17, July 30, October 7, November 25 and December 8, 2015 meetings were approved as published.

FIRE DEPARTMENT

Chief Saidler discussed call activity for the Fire Department with total calls in 2015 on pace to be a record year. He brought the Commissioners up to date on the status of the new Fire Station.

POLICE DEPARTMENT

Chief Malasuk discussed past activity for the Police Department for 2015 including special programs such as Shop with a Cop, working with the school district on security detail, new equipment purchased, and special training obtained in 2015.

CLOSED SESSION

By motion duly made, seconded and unanimously approved, the Commission adjourned into closed session pursuant to Wis. Stat. §19.85(1) (c), to consider employment, promotion, compensation or performance evaluation data of any public employee over which the governmental body has jurisdiction or exercises responsibility; specifically, to discuss establishing an eligibility list for Police Officer at the Greendale Police Department, as well as discuss the Captain promotion at the Greendale Fire Department.
