

GREENDALE POLICE & FIRE COMMISSION

These are the minutes of a regular meeting of the Greendale Police & Fire Commission held on Tuesday, January 29, 2013 at 7:30 AM in the Court Room of the Greendale Safety Center, 5911 West Grange Avenue, Greendale Wisconsin.

ROLL CALL

All members of the Commission were present for this meeting, along with Police Chief Robert Malasuk and Fire Chief Timothy Saidler.

POLICE DEPARTMENT

Chief Malasuk reviewed the activity for the Police Department over the past year.

FIRE DEPARTMENT

Chief Saidler handed out activity reports for the months of September through December, 2012.

HIRING / PROMOTIONS

Chief Malasuk stated Lieutenant Jeff Zainer has been with the Police Department for 27 years and has announced his intent to retire in August. Due to his retirement, there will be vacancies everywhere from Lieutenant down. Chief Malasuk would like to begin with hiring a police officer.

A motion was made by Commissioner Weyer to allow the hiring and promotional process to begin, seconded by Commissioner Kuzmanovic, with unanimous approval by the Commission.

Chief Malasuk recommended that Lieutenant Jeff Zainer be promoted to Captain. Lieutenant Zainer is a supervisor who is respected by everyone and has earned the right to be promoted to Captain. Chief Malasuk stated he has discussed this with the Village Manager who agrees it is appropriate.

A motion was made by Commissioner Farley to promote Lieutenant Zainer to Captain, seconded by Commissioner Weyer, with unanimous approval by the Commission.

COMMISSION OFFICERS

Commission President Wilmoth stated he has been the President for a long time, over 10 years, and believes it would be good for the Commission to have someone else taken on the leadership role. He stated he would stay on as President until April 1st to clean up issues that may still be open, such as updating rules or policies.

Commissioner Weyer stated he would be willing to take on the responsibilities of Commission President. No other commissioners voiced interest.

Commissioner Wilmoth nominated Commissioner Weyer as next president, Commissioner Kuzmanovic seconded, passing with unanimous approval by the Commission.

COMMISSION

The Commission's next regular meeting, if needed, was tentatively scheduled for Tuesday, April 9, 2013 at 7:30 AM in the Courtroom of the Greendale Safety Center. The Commission President, David Wilmoth, may call a meeting of the Commission as the need arises.

This meeting was adjourned at 8:15 AM.
